

## DELINQUENT CONTRIBUTORS

Signatory employers are required to submit fringe benefit contributions by the 10<sup>th</sup> of the month following the month in which the hours were worked.

The Trustees have decided that it is in the best interest of the Indiana Laborers Combined Funds (the Fund) and its participants to implement a policy whereby the Fund will make available a list of those employers that are 30 or more days delinquent in making contributions, or have other contribution issues. The delinquent list will be updated on this site on a weekly basis. The delinquent status of an employer can change on a daily basis, and because of these daily changes, viewers of this list should be cautious about relying on this list alone to confirm the delinquent status of an employer. If you are concerned with the fringe benefit status of any employer on this list, you should contact the company to see if they are delinquent. You may then contact this Fund to confirm the employer's representations.
