

## DELINQUENT CONTRIBUTORS

UPDATED 1-30-12

Signatory employers are required to submit fringe benefit contributions by the 10th of the month following the month in which the hours were worked. The Trustees have determined that it is in the best interest of the Indiana Laborers Combined Funds (the Fund) and its participants to implement a policy whereby the Fund will make available a list of those employers that are more than 30 days late in making contributions, or have other delinquency issues. The delinquent list will usually be updated on this site on a weekly basis. The delinquent status of an employer can change on a daily basis, and because of these daily changes viewers of the list should be cautious about relying on this list alone to confirm the delinquent status of an employer. If you are concerned with the fringe benefit status of any employer on this list, you can contact the company to ask about the delinquency. Then you can call this office to confirm the information.
